## II. Definitions of Terms

---

1. In these Price Conditions, the following terms are used according to the meanings as detailed:
  - 1.1. Assistance Dogs  
Assistance dogs are, according to §39a of the Austrian Federal Law for Disabled Persons ("Bundesbehindertengesetz") guide dogs, service dogs and signal dogs that assist people with handicaps. Such dogs are entered – according to their function – on the disability ID as follows:
    - "Possesses a service dog in order to assist with limitations due to disabilities".
    - "Possesses a signal dog in order to assist with limitations due to disabilities".
    - "Possesses a service and signal dog in order to assist with limitations due to disabilities".
  - 1.2. Charge for Carriage  
Consideration that shall be paid for utilization of transportation service, not excluding other forms of consideration.
  - 1.3. Transportation Credential  
Credential for transportation ("ticket") issued subject to a contract for carriage which entitles one or multiple person(s) to one or more specific form(s) of transportation (possibly including live animals and luggage). The transportation credential is transferable if it is not issued under a specific name and the journey has not yet commenced. Absent evidence to the contrary, the transportation credential is deemed to be verification of the conclusion and content of the contract for carriage. Numbered tickets issued to group travelers are also valid as transportation credentials.
  - 1.4. Fare  
Price for transportation of persons.
  - 1.5. FestungsCard  
Discounted combo ticket for use of the FestungsBahn funicular and admission to publicly accessible areas of Hohensalzburg Fortress.
  - 1.6. Luggage Fare  
Fee for the transportation of hand luggage.
  - 1.7. Youths  
Persons ages 15 to 18 (up to the day prior to their 19<sup>th</sup> birthday). In the event of doubt, proof of age shall be presented in the form of a photo ID which also shows the date of birth.
  - 1.8. Children  
Children are persons ages 6 to 14 (up to the day prior to their 15<sup>th</sup> birthday).

## II. Definitions of Terms

---

- 1.9. Apprentices
- Persons in a legally accredited instructional setting and who attend an industrial training site within Austria, or close to the Austrian border in a foreign country, on at least 3 days per week and for whom a family allowance is claimed.
  - Consistent with the Family Benefits Act as amended ("Familienlastenausgleichsgesetz", Federal Law Gazette I No. 23/1999), persons are deemed equivalent to apprentices who are participants in courses of study and programs at educational institutions as addressed in the "Jugendausbildungs-Sicherungsgesetz", or who are undergoing pre-vocational training according to the Vocational Training Act (1998 amendment to the "Berufsausbildungsgesetz").
- 1.10. People with Handicaps
- People with handicaps are persons,
- who are able to present a disability card according to §40 of the Austrian Disability Act ("Bundesbehindertengesetz") with the endorsement "The holder of this card is entitled to claim a fare discount per the Austrian Disability Act, or
  - who are able to present evidence of a degree of disability or diminution of earning capacity of at least 50%, or
  - who are able to present a disability card according to §40 of the Austrian Disability Act with official confirmation of diminished earning capacity of at least 50%, or
  - who claim supplemental family assistance according to §8 par. 4 and 7 of the Family Benefits Act 1967, insofar as there has been a determination of diminished earning capacity of at least 50%, or of prospective long-term inability to independently provide for themselves, or
  - who claim a care allowance, care bonus, allowance for the blind or comparable support, or
  - who claim an invalidity pension (reduction of earning capacity of at least 50%) documented by means of attestation from the applicable social insurance provider, federal social services or the payment authority, or who are eligible for benefits due to a mobility impairment of at least 50%, or

- who are entitled to supportive care according to the Austrian Veterans Care Act (“Heeresversorgungsgesetz”) with a diminution of earning capacity of at least 50%, or who are from other countries and likewise entitled to such supportive care, subject to production of a disability card similar in nature which clearly details the first and last names, place of residence and date of birth, along with a diminution of earning capacity of at least 50%.

In case of doubt, the claimant must present qualifying documentation (e.g. disability card according to §40 of the Austrian Disability Act, or an equivalent document, or a [provisional] “ÖBB-ÖSTERREICHCARD Spezial” in combination with a photo ID showing the claimant’s age).

### 1.11. Month

A time period from the calendar day of one month to the prior calendar day of the following month (between 28 and 31 days; “fluid date”).

### 1.12. School Children

- enrolled pupils at a public school or an Austrian school accorded public status, or
- enrolled pupils attending an equivalent school in a foreign country close to the Austrian border which is more convenient to reach than an Austrian school, pursuant to approval by the public school authorities if the child is still of compulsory school age, or
- pupils who attend a school which falls under the provisions pertaining to training for nursing professions, medical-technical professions or paramedic services, or
- enrolled pupils of an Austrian school which, in accordance with § 12 of the Compulsory Schooling Act (“Schulpflichtgesetz”, Austrian Law Gazette No. 76/1985), is certified as suitable for fulfilment of compulsory schooling requirements, or
- enrolled pupils of an Austrian private school that has been granted a publicly regulated school designation (§11 of the Private School Act, “Privatschulgesetz”, Austrian Law Gazette No. 244/1962).

### 1.13. Seniors

- Persons who are in possession of a valid pensioner’s ID card pertinent to the reduced fare schedule applying to bus lines in Zone S.
- Persons who are in possession of a valid SVV “Edelweiss Ticket” for senior citizens.

### 1.14. Week

Time period of seven consecutive calendar days.

## III. Fare Conditions

---

### 2. Timetable

The FestungsBahn Funicular operates year-round with the exception of maintenance periods. The precise dates of commencement and cessation of service are announced on the homepage of Salzburg AG Tourismus.

The carriages of the funicular run regularly every 10 minutes, and at shorter intervals as needed.

The FestungsBahn has the right to extend or shorten its published hours of operation.

### 3. Transportation Credentials

3.1. Transportation credentials are valid on the day they are redeemed for one ride up, one ride down, or for a roundtrip ride up to the fortress and back.

Weekly and monthly tickets are issued both at the valley station as well as the mountain station and are valid for a period of one week or one month.

3.2. The transportation credential must be presented or handed over for inspection immediately upon the request of any FestungsBahn employee; If the passenger is unable to present a valid transportation credential for inspection, the passenger shall pay double the standard fare for a ride up the mountain. Upon demand, the transportation credential must be relinquished upon conclusion of the ride in question.

3.3. With a transportation credential from the MönchsbergAufzug Lift for a ride down the mountain as well as a transportation credential for a roundtrip ride with the ride back down as yet unused, the credential may also be used on the same day of issue for a ride down on the FestungsBahn funicular.

3.4. No compensation is provided for a transportation credential which has only been used in part with respect to roundtrip service, or for lost or (partially) unused weekly or monthly tickets.

3.5. A transportation credential is invalid if

- the contents thereof have been altered without authorization, or
- due to its condition its validity cannot be verified, or
- it does not meet the fare conditions in some other way, or it is being used contrary to the fare conditions, or
- it is only valid in combination with an ID and the applicable ID cannot be produced or is invalid.

Invalid transportation credentials will be confiscated by the employee authorized to conduct the ticket inspection.

### III. Fare Conditions

---

#### 4. Fares

The fares for use of the FestungsBahn Funicular are listed in the FestungsBahn Fare Schedule. If carriage proves impossible as a consequence of decisions made by the FestungsBahn, the cost of the fare for the ride up or down the mountain will be reimbursed in full. With respect to transportation credentials for return service that have only be used in part, the holder will at least be reimbursed the fare for the unused ride down or ride up the mountain. Aliquot refunds for commutation tickets are not possible.

If carriage does not occur due to reasons for which the passenger bears responsibility, the passenger will have no right to a refund.

#### 5. FestungsCards

The prices for FestungsCards are listed in the FestungsCard Price Schedule. Insofar as no individual exceptions are stipulated, FestungsCards are sold during opening times of the interior areas of Hohensalzburg Fortress.

Entrance prices entitle the holder to

- admission to publicly accessible areas of Hohensalzburg Fortress and admission to the Marionette Museum (operated by Dr. Berer KEG) under the auspices of *Salzburger Burgen- und Schlösserbetriebsführung*, Mönchsberg 34, 5020 Salzburg

#### Basic Ticket:

The Basic Ticket includes roundtrip service on the FestungsBahn Funicular (from the Sperrbogen, only the ride down), admission to the outdoor area of the fortress grounds, admission to the Fortress Museum, the Rainer Regiment Museum, the Panorama Tower and the Marionette Museum.

#### All-Inclusive Ticket:

The All-Inclusive Ticket is a basic ticket which also entitles the holder to admission to the Princes' Chambers (incl. introductory room).

#### Panorama Ticket:

The Panorama Ticket includes roundtrip service on the FestungsBahn Funicular as well as admission to the fortress grounds and Panorama Tower. It may be validated from May to September between 8:30 – 10 a.m. as well as between 6 – 8 p.m. and from October to April between 4 – 5 p.m. at the bottom ticket office of the FestungsBahn or along the footpath. The Panorama Ticket is available year-round from the Webshop of *Salzburger Burgen- und Schlösserbetriebsführung*.



### III. Fare Conditions

---

All persons entitled to complimentary carriage on the FestungsBahn, holders of commutation tickets as well as those performing national social or military service (in uniform) enjoy free access to the publicly accessible outdoor areas of Hohensalzburg Fortress.

FestungsCards are generally sold both at FestungsBahn ticket offices as well as the "Sperrbogen" ticket window up to one hour prior to the interior area of Hohensalzburg Fortress closing.

Various other ticket options may be purchased at other ticket outlets such as the Webshop operated by *Salzburger Burgen- und Schlösserbetriebsführung* and other external ticket distribution partners.

## IV. Fare Discounts

---

### 6. Children

Accompanied children ages 5 and under, with no more than two children per chaperone, are transported free of charge. Children ages 6 to 14 (until one day prior to their 15<sup>th</sup> birthday) are transported for the children's fare.

### 7. Ticket Passes

#### 7.1. Weekly Tickets

Weekly tickets are transferable and valid within a period of one week for an unspecified number of journeys.

#### 7.2. Monthly Tickets

Monthly tickets are valid within a period of one month for an unspecified number of journeys.

##### 7.2.1. Transferrable monthly ticket

Entitles the user in question to an unlimited number of rides on the FestungsBahn.

##### 7.2.2. Personal monthly ticket, "Stadtbergticket"

Entitles the user in question to an unlimited number of rides on the FestungsBahn Funicular and the MönchsbergAufzug Lift. Non-transferable; if required by ticketing or inspection staff, a photo ID must be presented.

##### 7.2.3. Monthly ticket for school children and apprentices

Entitles the holder to an unspecified number of rides on the FestungsBahn Funicular. Only issued to school children and apprentices with an appropriate ID (school ID, s'COOL-CARD). Non-transferable; if required by ticketing or inspection staff, a photo ID must be presented.

### 7. Groups

The fare discount is granted if the prescribed fare for at least 10 participants is paid collectively by a single passenger.

### 8. Youth Groups

The fare discount for children, pupils and youths is granted if the prescribed fare for at least 10 participants is paid collectively by a single passenger. The group must be supervised by an authorized chaperone; one chaperone is transported at the youth-group fare for every 10 participants.

## IV. Fare Discounts

---

- 9. Seniors**  
Seniors are transported for the usual price afforded to seniors according to the FestungsBahn Fare Schedule.
- 10. People with Handicaps**  
People with handicaps and/or restricted mobility as well as an attendant if required will receive discounted tickets.  
An attendant will only be granted a discount insofar as they push the person in a wheelchair and/or the disability card indicates a need for the attendant.

## V. Miscellaneous

---

### 11. **Companion Animals**

Only those live animals that can be transported without endangerment or nuisance to other passengers may be brought along. In case of doubt, determination as to whether the animals may or may not be transported will be made by the employee who is present.

The passenger who brings the animal is liable for any damages that it may cause.

Dogs that are not housed in containers will only be transported if they are wearing a muzzle and are either carried or kept on the floor on a short leash. Appropriately identified assistance dogs and therapy dogs according to §39a of the Austrian Federal Law for Disabled Persons ("Bundesbehindertengesetz"), including guide dogs for the blind, service and signal dogs, as well as police dogs – also without a bite-proof muzzle – will be transported free of charge.

Animals are permitted for transportation if it can be expected that transportation will not impair safe operation, the owner keeps the animal safe during transportation and any passengers traveling with the animal do not raise any objections. Animals may only be transported with a muzzle and leash or in a suitable and closed transport box

### 12. **Hand Luggage**

Hand luggage with a total weight up to 30 kg is fundamentally transported free of charge.

Hand luggage with a total weight of more than 10 kg up to a maximum of 30 kg will only be transported if, in the opinion of the FestungsBahn staff member, it is suitable for transportation with regard to its shape, size and other characteristics, if it does not injure persons or damage or contaminate equipment, operating materials or other objects and if the safe existence and operation of the cable car is not endangered by its transportation.
